WELCOME AND INTRODUCTIONS

Tom Bottoms, Chair, called the meeting to order at 12:45 pm. Introductions were made, and a quorum was established.

REVIEW AND APPROVED SEPTEMBER 20, 2024 MEETING MINUTES

Bottoms requested the TASC review the minutes of the September 20, 2024, meeting.

MOTION: Dan Rodrigues moved to approve the September 20, 2024; meeting minutes as written; Sebastian Saa seconded. The motion passed by present members with a vote of 10 - 0.

DEPARTMENT/DIVISION/BRANCH UPDATES

Jenna Leal updated the TASC on a Highly Pathogenic Avian Influenza outbreak that has now impacted 278 Central Valley dairies to date. The Feed, Fertilizer, and Livestock Drugs Regulatory Services (FFLDRS) Branch is working with the Animal Health Branch to assist where needed and to implement biosecurity procedures. Leal briefly discussed mandated budget cuts across the department and how that is impacting each program.

Leal informed the TASC that feed, and fertilizer regulation changes are moving through the system. Personnel updates include Evelyne Ndiaye and Yanhong Li both being promoted into supervisory positions with commercial fertilizer and organic input material programs.

Mark Cady updated on FREP personnel changes, stating that Nicole Nunes will be on maternity leave until January 2025, and will return to work at 25% time. Cady further informed the TASC that Maria Tenorio Alfred joined the FREP team full time. The applications for new TASC members were approved by the Fertilizer Inspection Advisory Board and will be sent to the Secretary for appointment.

PRESENTATION

Dr. Gerry Spinelli gave a presentation highlighting California's nursery industry research needs and challenges.

REQUEST FOR PROPOSALS (RFP)

The TASC reviewed the current Request for Proposal (RFP) document. A discussion was held regarding the award amount for the grants and whether it could be increased, or whether different award amounts could be offered for research proposals versus outreach proposals. Dan Rodrigues suggested adding nitrogen management for grapevines biomass recycling. FREP staff discussed requiring Principal Investigators (PI) to include travel costs for FREP conference attendance in their budget.
